MINUTES of the MEETING of the BETCHWORTH PARISH COUNCIL held on MONDAY 3rd August 2015, at 8pm in the Hamilton Room.

Present: Councillors Hardy, Wilson, Docwra, Stow, Taylor, Higgins, District Councillor Potter, the Footpaths Officer and the Clerk. County Councillor Clack was present for part of the meeting.

Prior to the Meeting Martin Higgins signed the members Acceptance of Office form, witnessed by the Clerk, and signed a new Declaration of Members Interests form.

1. APOLOGIES FOR ABSENCE.

(116) Apologies were received and accepted from Councillor Savill.

2. MINUTES OF THE PREVIOUS MEETING.

(117) The minutes of the meeting held on 6th June July approved and signed by the Chairman as a true and correct record.

3. MATTERS ARISING

(118) Goulburn Green holly tree. A quotation to rejuvenate this tree and to prune the apple trees in the orchard had been received from Mattree too late for inclusion on the agenda, to be debated at the September meeting.

(99) Ockham Stack. It was agreed to send the letter drafted by Councillor Wilson. Chairman thanked Councillor Wilson for drafting the letter.

5. COMMUNITY POLICE REPORT.

(120) There was no police presence and no report had been received. Post meeting note: a report was received (7pm on day of meeting) outlining '1 x theft of bikes from outhouse'. No further information available.

6. OPEN FORUM.

(121) No members of the public present. However, District Councillor Potter raised issues with diverted buses during the Brockham roadworks.

7. TRANSPORT, HIGHWAYS AND FOOTPATHS.

(122) Footpaths Officer's report: Reported a fallen tree on the NDW to Surrey CC. Reported two instances of fly-tipping. Cleared & strimmed overgrowth on FP456; footpath on A25/Station Road by roundabout; footpath opposite BMC down to Kiln Lane. End of report.

(123) It was agreed that Bob Bartlett should be asked to contact the originator of the fly-tipping alert, requesting that, in future, they report the matter direct to SCC.

(124) It was noted that most school path hedges had been cut, therefore a letter had been sent to all properties requesting a hard-cut before March 2016.(125) Phase II of the Church path resurface was agreed in principle but the route for the new water supply needs to be agreed first.

(126) The complaint received regarding cycling on the school path was discussed and the option of further signage was discounted. It was agreed to broadcast the problem, asking cyclists to use the bridleway, in the parish magazine.

(127) Council rejected the request to purchase speed detection and display equipment.

(128) The Clerk reported that MVDC had requested that all instances of flytipping on private and on public land be reported. It was agreed to add this to the September parish magazine article.

(134) Councillor Wilson reported that Rupert Gibbs had agreed to adjust the Jubilee Pavilion seating within the next fortnight.

(135) Council approved the Footpath's Officer to purchase wood to repair broken fencing in the burial ground.

(136) Goulburn Green Play Provision Public Meeting. County Councillor Clack joined the meeting. After a lively debate there was agreement to publish an invitation to residents (no agenda), to use a show of hands to determine the need for a vote, to request permission from Brockham and Buckland to publicise the meeting, to ask for the assistance of David Hill in advertising the meeting. (nb the public meeting was discussed further under Any Other Business).

(137) Goulburn Green apple tree. Authority to draw up a list of apple trees for the WI was delegated to Councillor Wilson.

(138) Unleashed dogs in the burial ground. It was agreed to alert the MVDC dog warden to the problems with unleashed dogs in the burial ground.

(139) Planning Infrastructure Contribution Environmental Improvements grant. It was agreed that the Clerk apply for the remaining sum required to complete phase II of the church path resurface.

(140) The following memorial was approved: Karin light grey granite, honed 2'6" x 1'10" x 3" rose design sandblasted & base.
