BETCHWORTH PARISH COUNCIL

MINUTES of the MEETING of the BETCHWORTH PARISH COUNCIL held on MONDAY 7th September 2015, at 8pm in the Hamilton Room.

Present: Councillors Hardy, Savill, Docwra, Stow, Taylor, Higgins, the Footpaths Officer and the Clerk. 2 residents were present for part of the meeting.

1. APOLOGIES FOR ABSENCE.

(153) Apologies were received and accepted from Councillor Wilson, District Councillor Potter, County Councillor Clack, PC Lee Munday and PCSO Dave Sadler.

2. MINUTES OF THE PREVIOUS MEETING.

(154) The minutes of the meeting held on 3rd August were approved and signed by the Chairman as a true and correct record.

3. MATTERS ARISING

(155) New water supply to burial ground/allotments. John Foreman met with Graeme Manton from the Estate and reported that the Estate are happy to allow access for the pipe across the land and offered to split the cost 50/50 with the Parish Council in exchange for also running a new supply to the farmyard. Graeme Manton to provide drawings, John Foreman & Councillor Stow to continue with this project.

5. COMMUNITY POLICE REPORT.

(157) The Clerk had received apologies from PCSO Dave Sadler and PC Lee Munday and a statement that no crimes had been reported in Betchworth during the previous month.

6. OPEN FORUM.

(158) 2 residents from Barley Mow Court were present to request that the Parish Council add some weight to their repeated requests to Polbond to repair the broken fence containing the undeveloped area of the Old Barley Mow site and to tidy the area. Councillor Hardy had inspected the area and it was agreed to write to Bob Primrose, MVDC Planning Enforcement Officer copying Polbond, requesting that a Section 215 notice be served.

Councillor Docwra agreed to contact Brockham PC regarding the illegal night time lighting at the storage yard.

7. TRANSPORT, HIGHWAYS AND FOOTPATHS.

(159) Footpaths Officer's report: Removed litter from salt/grit bin & surrounding areas, created signs requesting that no rubbish be placed in salt bins. Purchased timber and repaired broken fencing in burial ground. Cut down small tree in Sandy Lane. Investigated smashed windows in telephone box outside Betchworth House. Noted that the bins in the burial ground are very full.

- (160) It was agreed that Ian Docwra and Ian Wilson should attend the meeting with Gatwick Airport on November 4th.
- (161) It was noted that there had been chaos with the simultaneous closure of Betchworth & Brockham bridges and it was agreed that this should be reported at the next Highways Forum.
- (162) The signs near the private road to Quarry Cottages was discussed, it was felt that the signs were on private property (owner unknown) and no action is to be taken. However, the tree surgeon sign on the 'Something Special' fence has been in place a long time and it was agreed to request removal of this sign.
- (163) Councillor Docwra reported several redundant roadworks signs on Kiln Lane/Old Reigate Road.
- (164) It was noted that the school have made a very hard cut of their hedges, however, there remains a small section that does not belong to them, Councillor Higgins confirmed that this hedging is the responsibility of SCC Highways.
- (165) It was noted that Bernard Hawkins had agreed to project manage phase II of the Church path and had consequently been given the go-ahead to start.
- (166) There was some discussion of the muddy state of the A25, Councillor Hardy agreed to contact J&J Franks to check that their wheel wash is in operation..

- (176) Goulburn Green Play Provision -the voting policy had been agreed prior to the public meeting where the policy of 1 vote per Betchworth elector was publicised. The notes from the public meeting were approved for publication on the website, notice boards and email distribution.
- (177) The following memorial was approved: Light Grey Granite, honed, 2' 3" x 1' 9" x 3" and base 3" x 2'0" x 12". black enamelled inscription: LOVE ENDURES ALWAYS HAS ALWAYS WILL DOUGLAS 1923 2014 PARKES 1930 2007 DOREEN YOUR LOVE WILL LIGHT MY WAY AND YOUR MEMORY WILL ALWAYS BE WITH ME
- (178) The following memorial was not approved: Light Grey Granite, honed open book, tickrests and base 24" x 26". Inscription to read: Jack Cooper (year of birth) 1998 (painted terrier head) Whisky Charity Cooper (year of birth) 2007 (painted cat head) Sailor. Guidelines prohibit a similar style of headstone, also portraits of the deceased are not allowed so follows that portraits of pets are not allowed. The naming of the pets also might imply that the animals are buried in the plot which is also prohibited.
- (179) Burial Ground. Following the complaint of an inscription plate being dislodged for the second time in two years Councillor Hardy and the Footpath

Officer had inspected the memorial. It was felt that there was an underlying design fault with the tilted plate and that it would not take very much at all to dislodge the plate.
