BETCHWORTH PARISH COUNCIL

MINUTES of the MEETING of the BETCHWORTH PARISH COUNCIL held on MONDAY 3RD JULY 2017, at 8pm in the Hamilton Room.

Prior to the meeting it was agreed that Agenda Item 5. (Open Forum) would take place after Agenda Item 7. (Planning) and the Public Consultation Presentation by Guy Davies, MVDC.

Present: Cllrs Hardy (Chairman), Edwards, Higgins, Rogers, Savill, Wilson and Clerk (Marion Hallett). Bernard Hawkins, Burial Ground Officer and John Foreman, Footpaths Officer were present. One member of the public and one guest speaker were also in attendance for part of the meeting.

1. APOLOGIES FOR ABSENCE.

(104) Apologies were received and accepted from Councillor Docwra.

2. DECLARATIONS OF INTEREST.

(105) There were no Declarations of Interest recorded at this meeting.

3. MINUTES OF THE PREVIOUS MEETING.

(106) The minutes of the meeting held on 5th June 2017 were approved and signed by Councillor Hardy as a true and correct record.

4. COMMUNITY POLICE REPORT.

- (107) A non-detailed police report was received and noted by Councillors.
- (108) Following complaints relating to the antisocial behaviour of the driver of a Porsche (Minute No.62) the Councillors were informed that the driver had received a notice from Police requesting a stop to this activity.
- (109) It was noted that Karen Coyne has replaced Inspector Richard Hamlin as District Commander in Mole Valley.

5. TRANSPORT, HIGHWAYS AND FOOTPATHS.

- (110) Footpath Officer delivered a verbal report. In summary: clearance of three blocked drains, reported dangerous overhanging trees in Sandy Lane and acknowledge quick response by MVDC to clear, inspected footpath between Parrs Corner and shop; acknowledged poor patching, path has narrowed and tree roots causing damage to pavements although no further action to be taken at this time.
- (111) Footpaths Officer confirmed he will remove the Black Bins from the Burial Ground/Allotments now that red BIFFA bin is in-situ.
- (112) Swings and slide checked on 15th and 22nd June and 2nd July and remain fit for use.
- (113) Further discussion regarding Working Party to clear debris and overhanging foliage from the Station/Coombe footpath. Footpaths Officer provided a Risk Assessment to Clerk and has requested expression of interest to be sought for help via Parish Magazine and Clerk email. Councillor Savill has volunteered use of his front garden to assist with location for accessible waste disposal/location of skip. Proposed date for Working Party: 23rd September 2017
- (114) Footpath Officer has maintained a number of verges.
- (115) Noted that the School Path is overgrown and almost impassable in places, apart from the area from Walled Garden to the Nursery. Councillors agreed verges, hedges and overhanging debris from private properties must be proactively maintained and remain the responsibility of property owners in the absence of MVDC workforce. Clerk to send village email to this effect.

- (116) Noted correspondence form Cllr Potter that Brockham Betchworth footpath No. 51/52/457 was severely overgrown with weeds and vegetation.
- (117) Noted that damaged Wall is causing a dangerous obstruction on Pebblehill. Cllr Savill to discuss with owners.
- (118) Cllr Edwards Confirmed Goulburn Green will be partially resurfaced on the 6th and 7th July 2017. Clerk confirmed it had been previously agreed that resurfacing would be funded from existing budget and that no application for grant money had been made in this instance. Clerk to make enquiry for grant money available for future path maintenance and resurfacing. (119) 8.30pm Footpaths Officer left the meeting.

6. PLANNING.

- (120) 8.30pm Guy Davies, Planning Policy Manager, MVDC joined the meeting
- (121) An informative presentation on the Public Consultation entitled "Future Mole Valley" was delivered by Guy Davies. See Appendix A.
- (122) Councillors were invited to ask questions; Councillor Hardy commented that this has been covered in previous years, and will our views be taken into account?
- (123) MVDC Representative invited the Parish Council as a body to respond to consultation. Clerk to respond on behalf of Parish Council.

Location of bench TBA, hardstanding if required, request Ken Webb to fit.

(128) The memorial for "Zeal" was approved as per specifications received from Sherlock Funeral Service.

(129) Quote for repairs to Parish Council notice board located at the Post Office was approved (£186.00 inc VAT for two concrete spurs to secure posts).

(130) No councillors available to attend SES Seminar on 21st July.

(131) Response to be submitted to oppose the MVDC Consultation on threatened closure of Recycling Centres.
