BETCHWORTH PARISH COUNCIL

MINUTES of the MEETING of the BETCHWORTH PARISH COUNCIL held on MONDAY 4th SEPTEMBER 2017, at 8pm in the Hamilton Room.

Present: Cllrs Hardy (Chairman), Edwards, Higgins, Rogers, Savill, Wilson and Clerk (Marion Hallett). John Foreman, Footpaths Officer was also present.

1. APOLOGIES FOR ABSENCE.

(157) Apologies were received and accepted from Councillor Docwra.

2. DECLARATIONS OF INTEREST.

(158) ONE Declaration of Interest was received from Councillor Wilson, relating to planning application reference number MO/2017/1412, the property belonging to a neighbour of Councillor Wilson.

3. MINUTES OF THE PREVIOUS MEETING.

(159) The minutes of the meeting held on 5th June 2017 were approved and signed by Councillor Hardy as a true and correct record with one minor amendment to item number 113, proposed date for Coombe working Party erroneously noted as 23rd September.

4. COMMUNITY POLICE REPORT.

(160) A non-detailed police report was received and noted by Councillors.

5. OPEN FORUM

(161) No Open Forum topics were raised.

5. TRANSPORT, HIGHWAYS AND FOOTPATHS.

- (162) Footpath Officer delivered a report. In summary: vegetation cleared from FP457, adjusted and secured gates at rear of churchyard. Two reports of fly tipping both responded to by MVDC within 24 hours.
- (163) Footpaths Officer confirmed Black Bins from the Burial Ground/Allotments deposited at Ranmore recycling centre.
- (164) Swings and slide checked on 31st July, 9th, 18th and 25th August and remain fit for use.
- (165) Further discussion regarding Working Party to clear debris from the Station/Coombe footpath, Councillors agreed to change the date and to combine with village litter-pick scheduled for 18th November 2017 and use Station Car Park as meeting point subject agreement by owners (Cllr Savill to check). Clerk to send Footpath Officer's article to Parish mag (Oct 17 edition) and notify previous volunteers of date change.
- (166) Footpaths Officer to patch tarmac worst potholed areas of Coombe footpath.
- (167) More maintenance has been necessary for Footpath Officer's strimmer following a fuel blockage. The Parish Council unanimously agreed to the proposal submitted by Cllr Wilson for the acquisition of a fully serviced second hand commercial strimmer at a cost of £100.00.
- (168) Following resurfacing to parts of the Goulburn Green footpath, Councillors agreed to submit a PIC fund grant application for £3009.00 to enable completion of resurfacing to the remaining middle section of the Goulburn Green path. Clerk circulated application to Councillors and will submit application on Council's behalf to MVDC asap.
- (169) Clerk to ask D Ellott to quote for edge maintenance to sections of Goulburn Green path which lead to Walled Garden.
- (170) Cllr Wilson commented that the location of the new BIFFA burial ground bin is a further distance away from the Burial Ground site. Cllr Wilson offered to create a sign to be attached to or near the Burial Ground gate for those wishing to use it.

(171) Signed and noted amendment to Minutes of Meeting held on 3rd July 2017 to minute number 113 – correct suggested date of Coombe working party should read 16th September, not 23rd September.

- (178) Councillor Wilson to seek clarification from B Hawkins regarding procedure for Burial ground plot acquisition and memorials.
- (179) Noted again that Noticeboard at Village Shop remains in disrepair and potentially requires entirely replacing having exhausted ad-hoc repairs. Councillors to inspect individually in order to make an informed decision as to how to proceed. Clerk to explore costs and options.
- (180) MVDC response to Parish Council letter of objection to closure of Ranmore Recycling Centre noted.

9. COMMUNITY.

- (181) Councillors had a brief discussion regarding possibility of Parish Magazine becoming a quarterly publication. Councillor Hardy confirmed publishing decisions are made between the Church and Editors.
- (182) Request noted for Church to host Harvest BBQ on Goulburn Green Risk Assessment received, albeit covered under Church's insurance. Request for grass cutting noted.
- (183) Data Protection Compliance Training 13th September Clerk to attend and report back if appropriate for Councillors to attend.
- (184) Cllr Wilson provided update on the BGHS bulb planting project including planting dates to note 14th October 10am at Buckland Pond (Buckland bulbs) and 22nd October to plant Betchworth bulbs
- (185) Noted that Clerk will attend the Surrey CC conference and SALC AGM on 12th October

- (186) Councillors held a brief discussion regarding developing plans for death/dementia joint information evenings. Awaiting further details from Linda Slater; Councillor Hardy expressed willingness for Parish Council to pay for room hire for the event.
- (187) Correspondence shared from a member of public who expressed disappointment at Parish Council's decision to cease advertising banners and displays from local groups on Betchworth Roundabout. Councillors agreed not to reverse decision at this time.
- (188) Councillor Hardy shared correspondence from a resident of The Street requesting financial help with replacing a traffic pole placed on a bend. Clerk to write to Highways/SCC to facilitate as Parish Council unable to help at this time. Clerk to let resident know PC's decision.
- (189) Clerk to report fly tipping of broken wall on Pebble Hill.

10. COMMUNICATIONS, IT.

(190) Cllr Edwards delivered a brief update on website development, new 'look' is almost complete and now focusing on content. Cllr Edwards and Clerk to meet to commence working on new content.

11. CLERK'S REPORT.

- (191) The Action List was reviewed and outstanding action items noted. Clerk to maintain, update and circulate on a monthly basis.
- (192) It was agreed Clerk should purchase 4No small 'No Cycling' signs to be secured with jubilee clips to existing posts along school path (minute ref 74/2017).

- (194) Councillors approved cost for Clerk to attend General Data Protection Regulation Compliance Training on 13th September.
- (195) Finance group provisionally booked 13th November to hold a budget meeting.
- (196) Noted that the Annual Return for y/e 31 March 2017 has been returned from BDO and has been approved and accepted by Betchworth Parish Council and Notice of Conclusion of Audit duly displayed on noticeboards and website. Two issues were raised, both relating to the documenting of Fixed Assets, which have been duly noted along with details of action to be taken.
