BETCHWORTH PARISH COUNCIL

MINUTES of the MEETING of the BETCHWORTH PARISH COUNCIL held on MONDAY 4TH MARCH 2019, at 8pm in the Hamilton Room.

Present: Cllrs Hardy (Chair), Rogers, Winter, Edwards, Higgins and Clerk (Marion Hallett). Footpaths Officer (FO) and District Councillor Simon Budd attended part of the meeting.

1. APOLOGIES FOR ABSENCE.

(345) Apologies were received from Councillor Wilson. The Burialground Caretaker was also absent.

(346) Councillor Hardy communicated to those present that she had accepted a resignation prior to the meeting from Councillor Richard Savill effective immediately.

2. DECLARATIONS OF INTEREST.

(347) No Declarations of Interest were received.

3. MINUTES OF THE PREVIOUS MEETING.

(348) The minutes of the meeting held on 4th February 2019 were approved and signed by Councillor Hardy as a true and correct record.

4. COMMUNITY POLICE REPORT.

(349) The monthly police report was presented to Councillors, acknowledging Crimes and noting superglue incident on the Nursery gate lock. No incident figures were provided to the Clerk this month. Councillors acknowledged a number of free Selecta DNA kits are still available to members of public; Clerk to communicate to Parishioners via village email. (350) Following previous discussions with Police, Councillors discussed the appearance of a speedwatch device on The Street during School half term week, despite a specific request via the Clerk for a survey not to be carried out during this week. It was also noted that the device was poorly positioned, being on a tight bend and therefore unlikely to yield results which could prompt the necessity for traffic calming measures.

5. OPEN FORUM.

(351) No matters were raised.

6. TRANSPORT HIGHWAYS AND FOOTPATHS

(352) Footpaths Officer (FO) delivered the following report. In summary; litterpick in conjunction with Great British Spring Clean confirmed for Saturday 13th April. Three new volunteers have confirmed availability to join the litterpick. Bridge over ditch at Brockham Park repaired by Brockham Park Management Committee (£300). Damaged area around manhole cover near Betchworth VH was inspected by Thames Water but will likely require road closure to fix properly. Carbuncle reported along Wonham Lane repaired. Lectern on Goulburn Green has been pushed over – FO volunteered to refurbish woodwork and enquire regarding appropriate materials for the sign displayed inside. Clerk to find details of original manufacturer. FO suggested repositioning the lectern closer to fence when ready to reinstate. FO and Councillor Hardy had both inspected pruning and approved work. Play equipment checked on 4th 15th and 26th February 2019 and remains fit for purpose. (353) Councillor Winter highlighted the necessity for traffic calming discussions to continue. Councillors agreed to revisit once results from speedwatch surveys were available. (354) Following the resignation of Councillor Savill those present discussed the need for an alternative representative from the Parish Council to attend the forthcoming Surrey & Sussex Community Rail Partnership meeting scheduled for 3rd April 2019. Councillor Hardy to discuss with Councillor Wilson.
