Footpaths

• Chased up Countryside on the fallen post by The Coombe on Pebblehill – again acknowledged that this is on the 'to do' list. I stated that this should be given priority due to the number of DOE walkers, Countryside agreed to contact Rambles Volunteers to get this fixed sooner. Further email confirms that this is on the list of jobs to be scheduled but is currently a priority 3 (low priority). Now fixed

• Bridleway 459 has been cleared of overgrown hedges to reveal the sign, landowner has been spoken to regarding parked cars to ensure that enough space is left for horses

Highways/ Rail

- Chased installation of the gateways received response stating that gateways have been delayed due to an issue with the provider, and are now scheduled for early May installation, now notified end of May
- Reported low hanging trees on Pebblehill following request from Parishioner minute number 408. Acknowledged by SCC ref number 2589988 and resolved
- Issued letter to GWR/South East Corp regarding the lighting on Betchworth Station and requesting it to be switched off at night to support our dark skies policy various communication re issue. Lights were set up temporarily due to power issues, waiting for a date for them to be removed. Clerk will keep on review and manage with parishioner.
- Reported leaning fence on old Barley Mow site to Highways ref number 2607824 comment received back stating that as it is not encroaching the road it is not highways issue it is the landowner, I have gone back requesting that they are contacted by SCC to address, now contacted Building Services. SCC have relinquished ownership stating that we need to write a letter to the owner. Building Control has acknowledged and requested further information.
- Chased Highways regarding the planned investigation into the alleged 'broken drain on Pebblehill' as
 it was acknowledged an investigation would take place in this financial year Ref 2188923 also
 reported the standing water that is currently there to be cleared. Given new ref number 2611958.
 Received notification that these have been fixed I have requested details as to what has been done.
 Survey of dissatisfaction completed due to lack of communication
- Made contact with the police asking for advice regarding the boundaries of responsibility with regard the damage to the verges on the bottom of Pebblehill as response back from SCC was not clear. It was reiterated that the verges are SCC responsibility and a highways issue. Clerk to go back to Highways, further evidence received regarding damage escalated to Highways and County Cllr Clack.
 Confirmation received that Traffic Commissioner are unable to intervene as the vehicles causing damage are visiting the site. This will be discussed with Highways and County Cllr Clack at the end of May at our meeting to agree a way forward to communicate.
